



2021 Australian Body Art Festival Market Stall Registration Form

The Australian Body Art Festival is being held on the 9th, 10th & 11th April 2021 and we invite you to register for a market stall at this unique event. Please note there is **limited availability**, so your prompt response and payment is required to ensure you are able to participate in this exclusive event.

The event in the past has attracted huge crowds and is an outdoor event. In 2021, due to Covid19 restrictions, we will be changing the program to incorporate sessions of 500 per session over the extended weekend period. Competitions will be conducted from late afternoon Friday 9th April to early evening Sunday 11th April with speed painting competition and entertainment on the main stage.

Operational times for food vendors and stallholders are **Friday 9th April from 4pm to 8pm, Saturday from 7:30am to 7:00pm and on Sunday 11th April from 7:30am to 5:30pm**. The event is held in **APEX Park Cooroy** which provides greater visibility and access for a limited number of food vendors and market stalls. Market stalls will be situated in and around the competitions, food area and amenities. There will be overnight security on both Friday 9th and Saturday 10th April. Costs for a **3m x 3m** space for the extended weekend is **\$165 inc. GST**. If you require a **6m x 3m** space for the extended weekend the cost is **\$330 inc. GST**. Due to Covid19 event restrictions, allocated and approved spaces are for the entire weekend. There are no daily rates.

Necessary Registration and License Certificates are to be displayed as required. All electrical equipment must have valid tag and testing certification. All Food/Alcohol/Health statutory requirements are to be adhered to. Public and Product Liability insurance to the value of \$20,000,000 is required and is to be kept current at all times. **A copy of these documents is required immediately upon acceptance*.*
